Notice is hereby given that the Board of Directors of Grand Mission Municipal Utility District No. 1 will hold a **regular** meeting, open to the public, on **MONDAY, 11 MARCH 2019**, at **11:30 a.m.**, at the offices of Coats Rose, P.C., 9 Greenway Plaza, Suite 1000, Houston, Texas, outside the boundaries of the District, to consider and act upon the following matters:

1. Minutes of the meeting of 11 February 2019;
2. Tax Collector's Report, including approval of disbursements from the District's tax account;
3. Bookkeeper's Report, including:
 - (a) authorize payment of the bills of the District and of the regional facilities administered by the District;
 - (b) review amounts due for regional facilities;
 - (c) review Investment Report for the District and the regional facilities;
4. Old business, including:
 - (a) status of law enforcement services (Fort Bend County Contract Deputy Program); communication from a resident regarding services;
 - (b) landscape maintenance report;
 - (c) status of actions of the North Fort Bend Water Authority (the "Water Authority");
 - (d) status of solid waste collection services (Best Trash, LLC; contract expires 30 June 2019 with 60-day notice requirement); take any necessary action regarding same;
 - (e) review monthly website report (Off Cinco);
 - (f) consider request regarding proposed soccer clinic in the detention pond area;
5. New business, including:
 - (a) authorization for preparation of annual water conservation report for submission to the Water Authority;
 - (b) authorization to provide information to municipal utility districts receiving water from the District as required for the Water Quality Report;
 - (c) authorization to escheat funds to the Texas State Comptroller as required;

6. Operator's Report, including:
 - (a) report on status of operation of the District's facilities;
 - (b) termination of services to accounts delinquent in the payment of water and sewer service bills from the District; turn over uncollectible amounts to a collection agency;

7. Engineer's Report, including:
 - (a) review bids and approve awarding of contracts for projects in the District;
 - (b) consider approval of the District's Municipal Separate Storm Sewer System Year 5 Annual Report;
 - (c) status of extension of utilities to the 8.378-acre tract north of the Westpark Tollway (G&A Boring Directional);
 - (d) status of plans for development of the 9.5828-acre tract at the intersection of the Westpark Tollway and Grand Mission Boulevard;
 - (e) status of the proposed improvements to the regional water plants;
 - (f) status of the proposed construction of regional water plant number 3;
 - (g) review of contract for water purchased from the Water Authority and recommendations regarding changes in the contracted amount;
 - (h) status of the expansion of the regional wastewater treatment plant (T & C Construction, Ltd.), including revised construction schedule;
 - (i) status of renewal of the Permit to Dispose of Wastes for the regional wastewater treatment plant;

8. Attorney's Report, including proposed demand letter for payment of backcharge amount due to the District;

9. Executive session, pursuant to Open Meetings Act, Section 551.071, Government Code, if needed;

10. Action on items discussed during executive session;

11. Such other matters as may come before the Board, including:
 - (a) discussion about items to be listed on the agenda for future meetings; and
 - (b) schedule future meetings as necessary.
